**“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE PURCHASE REQUEST NO. 24-2360 ACCOUNTABLE FORMS AMOUNTING TO ONE MILLION FIVE HUNDRED FORTY-FIVE THOUSAND FIVE HUNDRED SIXTY-EIGHT PESOS AND TWENTY-FIVE CENTS (PHP 1,545,568.25) TO NATIONAL PRINTING OFFICE THROUGH NEGOTIATED PROCUREMENT – AGENCY TO AGENCY PURSUANT TO SECTION 53.5 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184.”**
