“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 23-5073 TO ZION ACCUPRINT PUBLISHING INC. AS A SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF POSTER (DISASTER PREPAREDNESS IEC MATERIALS) 20X30 INCH (GLOSSY 2000-2500 COPIES) UNDER BID NO. B-23-0257.”

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of **SUPPLY AND DELIVERY OF POSTER (DISASTER PREPAREDNESS IEC MATERIALS) 20X30 INCH (GLOSSY 2000-2500 COPIES)** under Bid No. **B-23-0257** POSTED in its website, the PHILGEPS and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 use the nondiscretionary pass/fail criteria and conducted a public bidding on November 21, 2023 that were attended by the following bidders/suppliers, to wit;
