"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 23-C0760 TO GPS REFRIGERATION AND AIRCONDITIONING SERVICES AS A SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF SPARE PARTS (AIRCONDITION) UNDER BID NO. B-23-0284."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF SPARE PARTS (AIRCONDITION) under Bid No. B-23-0284 POSTED in its website, the PHILGEPS and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 use the nondiscretionary pass/fail criteria and conducted a public bidding on December 12, 2023 that were attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed GPS that REFRIGERATION AND AIRCONDITIONING SERVICES shall undergo post-qualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on December 18, 2023 resulted in the following;
