## RESOLUTION NO. B-2024.04.25.12

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-C1088 TO BIG 8 CORPORATE HOTEL AS A SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF MEALS AND SNACKS WITH ACCOMMODATION UNDER BID NO. B-24-0041 Rebid."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF MEALS AND SNACKS WITH ACCOMMODATION under Bid No. B-24-0041 Rebid POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the Committee agreed that BIG 8 CORPORATE HOTEL shall undergo postqualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;
