"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3339 TO JASPER KISSA COMPUTER CENTER AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF COMPUTER SET WITH COMPLETE ACCESSORIES AND LAPTOP (HIGH-END COMPUTER SYSTEM) UNDER BID NO.
