RESOLUTION NO. <u>B-2025.06.10.02</u>

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 25-0746 TO ASMI PARTS AND SERVICES INC. AND GOLDENS DYNASTY MOTORS INC. AS A 2ND LOWEST CALCULATED AND RESPONSIVE BIDDER FOR SUPPLY AND DELIVERY OF WING VAN, CARGO TRUCK UNDER BID NO. B-25-0061."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Supply and Delivery of Wing Van, Cargo Truck under Bid No. B-25-0061 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on March 24, 2025, which was attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed that AUTOKID SUBIC TRADING CORPORATION shall undergo post-qualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on April 10, 2025, resulted in the following;



WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical, and financial requirements, AUTOKID SUBIC TRADING CORPORATION was found non-responsive due to the following reasons: during the verification of the Certificate of Authorized Dealership submitted by Autokid Subic Trading Corporation, discrepancies were found, including the identification of Mr. Kuper Hu—signatory of the certificate—as the Country Manager of FAW Philippines and not an authorized representative of Isuzu, raising doubts about the authenticity and validity of the dealership certificate; further confirmation from Isuzu Tagum, through its Branch Manager, also confirmed that Mr. Hu has no direct affiliation with Isuzu Philippines;

WHEREAS, the BAC further agreed that in the event that the bidder with the Lowest Calculated and Responsive Bidder (LCRB) fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with re-advertisement. If another bidding failure occurs even after the contract's re-bidding, the Procuring Entity is permitted to engage in a negotiated procurement.

WHEREAS, the TWG proceeded with the conduct of post-qualification for the two second-ranked bidders, ASMI PARTS AND SERVICES INC. and GOLDENS DYNASTY MOTORS INC., considering that they submitted identical financial proposals during the bid opening;

WHEREAS, based on the post-qualification conducted on May 23, 2025, it was found that GOLDENS DYNASTY MOTORS INC. had a previous contract with the PLGU-Davao de Oro for the procurement of a Mobile Kitchen Facility under Purchase Order No. 24091447, wherein they failed to deliver the vehicle brand initially offered, leading to contract cancellation due to non-compliance and unsatisfactory performance; thus, the bidder was found to be NON-RESPONSIVE in accordance with Section 34.3(b)(iii)(c) of RA 9184;

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical and financial requirements, the ASMI PARTS AND SERVICES INC. has been found to be the Lowest Calculated and Responsive Bidder;

WHEREAS, the detailed evaluation of bids was conducted on May 23, 2025, resulted in the following;

WHEREAS, if the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as LCRB and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;
