Dear **Mr. Salarda**;

We would like to notify you that **Construction of Double Barrel Box Culvert at Brgy. Dumlan, Maco (KKMP), Davao de Oro [Construction of 7.05m x 4.2m x 10m Double Barrel Box Culvert, Riprapping of 30.00 In.m., Installation of 24 In.m. Metal Guardrail and Remove and Replace 27.00 In.m. PCCP (0.30m thk.)] under CW24-009** after evaluation and post-qualification is hereby awarded to you being the **Lowest Calculated and Responsive Bidder with the contract price of Four Million Eight Hundred Fifty Thousand Eight Hundred Eleven Pesos and Eighty Nine Cents Only (Php4,850,811.89).**

Pursuant to **Section 37.2; Subsection 40.1** of the revised **IRR of RA 9184** "The winning bidder shall post the required Performance Security Ten (10) Calendar Days from the receipt by the winning bidder of this Notice.

Hence, the winning bidder is required to submit all the required documents prior to the signing of contract:

- 1.) Construction Schedule and S-curve
- 2.) Manpower Schedule
- 3.) Construction Methods
- 4.) Equipment Utilization Schedule
- 5.) PERT/CPM
- 6.) Construction Safety and Health Program approved by the Department of Labor and Employment
- 7.) Contractor's All Risk Insurance (CARI)
- 8.) Five (5) Sets of Quality Control Program (QCP) approved by the Provincial Engineer
- 9.) Performance Bond
- 10.) Other acceptable tools of project scheduling
- 11.) Program of Works (POW)

Failure to comply any of the above conditions; the Bid Security shall be forfeited and appropriate sanctions and existing laws shall be imposed.

Finally, **Section 40.2** in the case of the failure, refusal or inability of the bidder with LCRB or HRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall initiate and complete the post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid: this procedure shall be repeated until the LCRB or HRRB is determined for award. However, if no bidder passes post-qualification, the BAC shall declare the bidding a failure and conduct a re-bidding with re-advertisement. Should there occur another failure of bidding after the conduct of the contract's re-bidding, the Procuring Entity concerned may enter into a negotiated procurement.
