“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3023 TO DOUBLE J CONSTRUCTION AND SUPPLY AS A LOWEST CALCULATED AND RESPONSIVE BIDDER UNDER BID NO. CW24-022.”

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of **Construction of Bleacher and Stage, Bawani Gym, Mawab (Construction of 1 bay covered**

court with stage and 48 In.m. Bleacher) under Bid No. **CW24-022** posted in its website, the PhilGEPS and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of RA 9184 use the nondiscretionary pass/fail criteria and conducted a public bidding on September 17, 2024 that were attended by the following bidders/suppliers, to wit:

WHEREAS, given the complexity of Civil Works to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder's (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but maybe extended up to 45 days for technical evaluations;

WHEREAS, the detailed evaluation of bids conducted on September 20, 2024 resulted in the following;

WHEREAS, if the BAC determines that the bidder with the LCB passes all the criteria for post-qualification, it shall declare the said bid as the Lowest Calculated and Responsive Bid (LCRB), and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the **DOUBLE J CONSTRUCTION AND SUPPLY** as a Lowest Calculated Bid, its bid has been found to be responsive;

WHEREAS, the BAC further agreed that in the event that the bidder with LCRB fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid, if there is any. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with re-advertisement. If another bidding failure occurs even after the contract's re-bidding, the Procuring Entity is permitted to engage in a negotiated procurement.

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. **24-3023** to **DOUBLE J CONSTRUCTION AND SUPPLY** as a Lowest Calculated and Responsive Bidder for the procurement of **Construction of Bleacher and Stage, Bawani Gym, Mawab (Construction of 1 bay covered court with stage and 48 In.m. Bleacher)** under Bid No. **CW24-022**.
