WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Installation of Solar Lights at Malinawon, Mawab, Davao de Oro [Installation of 32 Units Solar Streetlights] under Bid No. CW25-010 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on January 30, 2025, that was attended by the following bidders/suppliers, to wit;

WHEREAS, given the complexity of Civil Works to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder's (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but maybe extended up to 45 days for technical evaluations;
