**RESOLUTION NO. NP-EC-12.17.08**

*Series of 2025*

**“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 25-6434 WITH A CONTRACT AMOUNT OF FOUR MILLION FIVE HUNDRED FIFTEEN THOUSAND PESOS (P4,515,000.00) FOR THE PROCUREMENT OF FOOD SUPPLIES TO DAVCOM CONSUMER GOODS TRADING, WHO OFFERED WITHIN THE APPROVED BUDGET FOR THE CONTRACT THROUGH NEGOTIATED PROCUREMENT – EMERGENCY CASES UNDER SECTION 35.2 OF THE IMPLEMENTING RULES AND REGULATIONS OF R.A. NO. 12009.”**

**WHEREAS**, on October 24, 2025, a Sangguniang Panlalawigan Resolution No. 0289-2025 was issued declaring Davao de Oro under a state of calamity due to the effects of the Magnitude 7.4 and Magnitude 6.8 Manay, Davao Oriental Earthquakes;

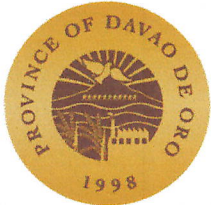
**WHEREAS**, on November 17, 2025, the Provincial Disaster Risk Reduction and Management Office (PDRMO) submitted a letter-request to the Head of the Procuring Entity (HoPE), through the Bids and Awards Committee (BAC), endorsing a list of items proposed for amendment in the Annual Procurement Plan (APP) to enable the immediate procurement of goods necessary for various response and initial recovery activities for the affected areas in the province;

**WHEREAS**, Emergency Procurement may be undertaken under Section 35.2 of the IRR RA No. 12009, the said procurement modality may be availed of under any of the following instances:

- a. imminent danger to life or property during a state of calamity;
- b. when time is of the essence arising from natural or man-made calamities; or
- c. Other causes where immediate action is necessary:
  - i. To prevent damage to or loss of life or property, or

- ii. To restore vital public services, infrastructure facilities, and other public utilities.
- d. the instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease, and other negative effects on human, physical, mental, and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption, and environmental degradation.

**WHEREAS**, during its regular meeting held on November 21, 2025, the Bids and Awards Committee (BAC) resolved to amend the Annual Procurement Plan to include a Supplemental Procurement Plan for the procurement of food supplies to address the urgent requirements arising from the earthquake that affected the Province of Davao de Oro, and hereby recognizes the extent of the damage caused by the said calamity and affirms its commitment to undertake all necessary actions to ensure the safety and well-being of the affected residents;

**WHEREAS**, the BAC further agreed to request the authority of the Head of the Procuring Entity (HoPE) to allow the BAC to negotiate the procurement of various food supplies with a legally, technically, and financially capable supplier, to be undertaken through Negotiated Procurement – Emergency Cases, in accordance with applicable laws and regulations of R.A. No. 12009;

**WHEREAS**, on November 26, 2025, the Head of the Procuring Entity (HoPE) granted the request of the Bids and Awards Committee (BAC) to negotiate the procurement of various food supplies to be undertaken through Negotiated Procurement – Emergency Cases considering the significance of these food supplies in supporting the response and initial recovery activities for the residents affected by the M7.4 and M6.8 earthquakes with epicenter in Manay, Davao Oriental, the BAC recognizes the urgency and necessity of the procurement to ensure timely assistance to the affected communities;

**WHEREAS**, on December 1, 2025, the submitted Project Procurement Management Plan (PPMP) from the requisitioning office was posted for inclusion in the Supplemental Procurement Plan, in order to formally incorporate the identified procurement requirements for the urgent acquisition of food supplies;

**WHEREAS**, on December 4, 2025, the requisitioning office submitted its Purchase Request for the procurement of food supplies with an Approved Budget for the Contract ₱4,515,000.00, to be undertaken through Negotiated Procurement – Emergency Cases to the BAC to support the response and initial recovery activities in the areas affected by the earthquakes in the province;

**WHEREAS**, said Purchase Request was posted on the Agency's official website on December 9, 2025, in compliance with transparency and posting requirements under applicable procurement regulations;

**WHEREAS**, on December 16, 2025, the procurement was directly negotiated with a legally, technically, and financially capable supplier, who is capable of fulfilling the urgent requirements of the agency in a timely manner;

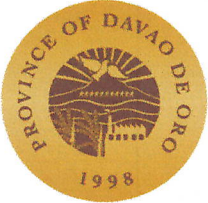
**WHEREAS**, after scrutinizing the required documents of the negotiated supplier, the BAC found the said supplier to be legally, technically, and financially eligible and capable of delivering the urgent requirements of the province.

**WHEREFORE**, on motion of Engr. Roderick M. Digamon and duly seconded by Dr. Antonio P. Ybiernas, Jr.; it was,

**NOW, THEREFORE**, hereby **RESOLVED** to recommend to the Head of the Procuring Entity to award Purchase Request No. 25-6434 with a contract amount of Four Million Five Hundred Fifteen Thousand Pesos (₱4,515,000.00) for the procurement of Food Supplies to Davcom Consumer Goods Trading, who offered within the approved budget for the contract through Negotiated Procurement – Emergency Cases Under Section 35.2 of the IRR Of R.A. No. 12009.


