has accepted the Bid for ONE MILLION FIVE HUNDRED THIRTY THOUSAND SIX HUNDRED

TERMS AND CONDITIONS:

- 1. The Contractor shall undertake the Construction of the Project for the Government in accordance with the Plans and Specifications.
- 2. The work to be undertaken of this Contract shall include furnishing of labor, materials and equipment with Contractor's capability and performance to complete the construction of the Project all in strict compliance with the terms and conditions.
- 3. The Commencement of the project shall be within seven (7) days upon receipt of Notice to Proceed (NTP) together with a copy or copies of the Approved Contract from the Provincial Government. Duration to complete the projects is One Hundred Forty (140) calendar days unless otherwise extended in accordance with the provisions of GPRA.
- 4. The Contractor shall take full responsibility and safety of all site operations as to Construction Methodology.
- 5. The Government shall not be liable for the loss of or damage to any of the Contractor's equipment, temporary works or materials stored at the jobsite.
- 6. The Government reserves the right to terminate or cancel the contract, should the Contractor fail to comply with any of the provisions of these terms and conditions.
- 7. Progress billing shall be processed subject to the evaluation and approval of the Provincial Engineer's Office and the Inspectorate Team of the Province.
